Pre-qualification Criteria

- A credit reference letter with a minimum code C rating from the bidder's bank indicating the level of credit facilities available.
- Original, Valid SARS Tax Clearance certificate.
- Preferably a minimum Level 4 B-BBEE Contributor as verified in accordance with the Codes of Good Practice for B-BBEE issued by the Dept. of Trade and Industry (DTI).
