No documents will be sold after this date and not having attended the compulsory clarification session.

Bidders are requested to hand deliver the bank deposit slip as proof of payment when collecting bid document.

## COMPULSORY CLARIFICATION SESSION

A compulsory Clarification Session will be held at 10h00 on Friday 22nd November 2013 at King Shaka International Airport – MSO Building, 3rd Floor, Charlie Boardroom.

## CLOSING DATE

The bid closes on Friday 6th December 2013 at 16h00. All bid documents must be in printed format and sealed in a clearly marked envelope / package marked with Bidder's name, Bid Number and Bid Description; and deposited in the bid box.

**LATE DOCUMENTS WILL NOT BE ACCEPTED.** Airports Company South Africa SOC Ltd reserves the right to withdraw, cancel or not award any tender issued.

## COLLECTION & DEPOSIT OF BID DOCUMENTS

Bid Documents can be collected and deposited at King Shaka International Airport, Airports Company South Africa, Reception, Ground Floor MSO (Multi-Storey Office) Building, MSO located in the Pick-Up Zone area.

## MANDATORY ADMINISTRATION CRITERIA

Proposals that do not meet any one of the following criteria (Valid proof/certification must be provided) will be disqualified and will not be evaluated further:

1. Acceptance of Terms & Conditions of Bid.
2. Attendance to Compulsory Clarification Session.
3. CIDB rating of 4CE or higher.

4. Valid proof of certification/affiliation to relevant bodies or institutions in their respective disciplines.
5. A valid and original Tax Clearance Certificate. The lack of an original SARS Tax Clearance with no explanation/application will result in disqualification.

## EVALUATION

Bidders need to comply first with Mandatory Administration Criteria. Only Bidders that comply will be evaluated further. The Evaluation will be done on a two phase approach.

Phase One: This proposal will be evaluated on functionality which is a hurdle criteria and not meeting the requirements will result in disqualification.

Phase Two: Only Bidders who achieved the minimum weighting in functionality will be considered for this phase.

This phase is based on the 90:10 preferential point systems with 90 reflecting Price and 10 reflecting B-BBEE recognition. In order to qualify for B-BBEE recognition, Airports Company South Africa SOC Ltd shall only accept DTI criteria as proof of B-BBEE status.
